Honourable Chair, Excellencies,

On behalf of the Commissioner for Human Rights of Poland and a group of +25 national human rights institutions from Bahrain, Bosnia and Herzegovina, Cyprus, El Salvador, Ethiopia, Fiji, Finland, Germany, Georgia, Guatemala, Jordan, Kenya, Korea, Malaysia, Myanmar, Palestine, Peru, Philippines, Romania, Slovakia, Slovenia, Sri Lanka, Thailand, Timor Leste, Ukraine

I would like to thank engaged Member States for their efforts to strengthen the human rights of older persons and every step undertaken towards a new comprehensive convention on the rights of older persons. We appreciate actions undertaken both in the forum of the Open-ended Working Group on Ageing (OEWGA) in New York and at the UN Human Rights Council (HRC) in Geneva, where on 29-30 August 2022 a Multistakeholders' meeting on the human rights of older persons was organized by the Office of the High Commissioner for Human Rights (OHCHR) in response to the request formulated in the first HRC substantive resolution on human rights of older persons. At this meeting 20 Member States in their informal contributions<sup>1</sup> not only expressed their explicit support for a new Convention but also indicated substantive content which should be included in this international, binding instrument. We expect that more Member States will join this group and will become leaders of change in championing the cause of the human rights of older persons, thus adding momentum to the shift from a social rights based perspective, towards a human rights based perspective on ageing and older persons.

We expect that on the way forward older persons, NHRIs and NGOs will be actively and meaningfully included in the consultations in the form indicated in the draft decision of the Working Group. We expect a meaningful participation which allows adequate time and space for dialogue, and through which our inputs will not just be listened to but also and taken into account, like those captured in the OHCHR summary report of the 2022 multistakeholders' meeting.

Older Persons of today and older persons of the future have been waiting for over a decade for this discussion to have a tangible, impactful and positive outcome – this is way overdue. Work on identification of gaps in international law as proposed by

Argentina at the 12<sup>th</sup> OEWGA Session<sup>2</sup> should be accompanied by a clear roadmap towards achieving the goal which is a new binding convention on the rights of older persons. We need a comprehensive instrument which will make older persons and their human rights more visible and universally recognized.
