DEPRIVATION OF LIBERTY AND HUMAN RIGHTS The prevention of ill-treatment in places of detention in Europe: Progress under way

« As of today 17 of the 47 member states of the Council of Europe have ratified the Optional Protocol to the UN Convention Against Torture. Only a few of these countries have adopted legislation setting up an independent mechanism to monitor all places of detention as required under the OPCAT and as had been recommended by the European Committee for the Prevention of Torture (CPT) for many years. Among the vanguard countries is France with its recent Act of 30 October 2007 on the creation of a "General Controller of places of detention", after the state of French prisons had been harshly criticized on numerous occasions by both national and international bodies. The French ombudsman (Médiateur de la République) and the Council of Europe Commissioner for Human Rights have supported and accompanied that project. That process raised both practical questions and matters of principle which needed to be solved by political decision. We have taken the initiative of this meeting to foster the sharing of thoughts and experiences amongst us, among those who are already on their way and those who are about to take that path. »
